SPECIAL POINTS OF INTEREST

- Allow paint to dry in cans, then place beside rollout cart for collection.
- Hazardous waste must be disposed of by other controlled methods. (See Below)
- Be sure to separate materials such as yard waste, C&D from other solid waste.
- Please bag or box small items and stack neatly by street edge.

The Town of Morehead City and Waste Industries are proud sponsors of our Annual “**Spring Cleanup**”. Residents on our **Roll-out cart service** are encouraged to clean up their porches, attics and yards, and placing items intended for collection by the street edge the weekend of **APRIL 11th & 12th, 2015**.

Items are to be placed neatly at the streets edge and **will be picked up during normal collection routes.**

Items that will be accepted during this cleanup are furniture, appliances, bedding, carpet, boxes, and all yard waste items, including firewood. Paint can be collected by removing the lids and allowing to completely dry. Once dry place by the street for collection. Major DIY or Contractors construction, demolition or landscaping debris **will not** be collected.

Most preparation requirements will be relaxed; however weight restrictions of 50 lbs. per item will still be required. Please keep debris, yard waste and Bulk items **separate** from each other. Place loose items in boxes or bags per weight restrictions. Also, when placing **yard waste** for collection be sure that placement is not under phone, power, or cable lines. When placing loose items out for collection, do so they will not become windblown.

Items that are classified as hazardous waste such as, electronics (e.g., TV's, computers, used motor oil, thinners, pesticides) etc. **cannot** be accepted as part of this cleanup. See the information below for instructions on how to dispose of these items.

Let's all pitch in and make our community a cleaner and safer place to live.



HOW TO DISPOSE OF HOUSEHOLD HAZARDOUS WASTE



The following is a list of items that cannot be included in this clean-up and information on proper disposal.

These items may be disposed of at the Carteret County Convenience site, located on Hibbs Road in Newport.

- Electronic Devices (TV's Computers)
- Waste Oil
- Automotive Batteries
- Tires
