Violation of Ordinance 2008-42 is a Civil Penalty of \$150.00 per occurrence. Each day the violation continues shall be a separate offense.

Sixth Street Daydocks Penalties

Violation of Ordinance 2008-43 is a Civil Penalty of \$50.00 per occurrence. Each day that the violation continues shall be a separate offense.

Buildings and Structures

Contractors-Bond: Every person required to register at the Office of the Inspection Department under Section 4-13 shall also give a good and sufficient bond in the sum of \$1,000 to be approved by the City Attorney.

Removal of Demolition of Property-Bond: In all cases of removal of building or a structure, a good and sufficient bond in the sum of \$500 shall be posted by the property owner or by his contractor at the time of application for a permit to ensure complete removal or demolition, including all rubble and debris.

Installing Energy Conservation Equipment, Etc.: Fees. Each application shall be accompanied by the most currently adopted fee on file in the Office of the City Clerk for the fiscal year and prorated by quarters to the end of such year. [See Minimum Residential Fee, permit].

Definitions of Life Safety Violations

Overcrowding – (\$500) A condition that exists when either there are more people in a building, structure or portion thereof than have been authorized or posted by the fire code official, or when the fire code official determines that a threat exists to the safety of the occupants due to persons sitting and/ or standing in locations that may obstruct or impede the use of aisles, passages, corridors, stairways, exits or other components of the means of egress.

Unauthorized Burning – (\$100) The burning of materials wherein products of combustion are emitted directly into the ambient air without passing through a stack or chimney from an enclosed chamber. Open burning does not include road flares, smudge pots and similar devices associated with safety or occupational uses typically considered open flames or outdoor cooking in approved appliance.

Blocked/ Impeded Exits – (\$200) Any form of obstruction in the required width of a means of egress. ("Means of Egress" is the continuous and unobstructed path of vertical and horizontal egress travel from any point in a building or structure to a public way, consisting of three separate and distinct parts: the exit access, the exit, and the exit discharge.)

Spraying Operations Not Conforming With Code – (\$100) Spraying flammable or combustible finishes without a properly installed spray booth or approved spraying area.

Alarm System Requiring Testing/Maintenance – (\$100) Failure to have required testing and maintenance conducted of fire alarm system(s), and to have required documentation of test(s).

Suppression System Requiring Testing/Maintenance – (\$100) Failure to have required testing and maintenance conducted of Alternative Automatic Fire-Extinguishing Systems and to have required documentation of test(s). Includes Commercial Hood and Duct systems, Wet –chemical, Dry-chemical, Foam, Carbon Dioxide systems, Halon systems and Clean Agent systems.

Sprinkler System Requiring Testing/Maintenance – (\$100) Failure to have required testing and maintenance conducted on fire sprinkler system(s), and to have required documentation of test(s).

Unauthorized Storage – (\$100) The storage of flammable, combustible or hazardous liquids or materials improperly stored and/or without a permit. (This violation applies to facilities that are required to report under the Hazardous Chemicals Right-to-Know Act.)

Note: All Fire Protection Permits are issued through the Morehead City Fire Department. Permits may be purchased at Station 2 located 4034 Arendell Street, Morehead City, N.C.

Note: The Town of Morehead City DOES NOT issue permits for OPEN BURNING or INDOOR PYROTECHNIC DISPLAYS. The use of indoor pyrotechnics and open burning is PROHIBITED within the corporate limits of the Town of Morehead City.

Note: A “Double” Permit Fee will be charged for any permit for which work was performed prior to a permit being issued.

False Alarm Schedule

Civil Citations issued following Three (False) Fire Alarm Trips (Per Calendar Year)..... \$ (**See Explanation Below**)

Each establishment within the Town of Morehead City will be allowed a total of **THREE (3)** false alarms per calendar year. Additional (false) fire alarms re-occurring after the third alarm will be subject to the following “Civil Citations” (**See note below defining “false alarms”**):

4 th occurring false alarm	\$100
5 th occurring false alarm	\$150

6th occurring false alarm **\$200**

For each subsequent false alarm (within the calendar year), the fine will increase in increments of **\$50** (example: 7th false alarm = \$250).

Fines for false alarm trips are issued for failure to maintain or make required repairs to fire alarm systems. Fines will not be issued for alarm trips due to natural causes, mischief or accidental activation of alarm systems that are maintained appropriately and functional.

Water/Sewer Taps and Extension Fees Outside Corporate Limits

Water Tap and Extension Fee:

Parcels of land will pay \$8.00 per lineal feet of frontage plus the cost of the tap[s].

Any additional water taps for the same parcel, the owner will be charged the cost of the taps.

Sewer Tap and Extension Fee:

Parcels of land will pay \$10.00 per lineal feet of frontage plus the cost of the tap[s].

Any additional water taps for the same parcel, the owner will be charged the cost of the taps.

NOTES:

If any of the above tap and extension fees are made from utility lines adjacent to property between the developers property and City limits extended by developers, 50% of the extension portion of fees shall be returned to the developer for all payments received during a period of five [5] years from the date of service being available for the developers extension.

Where water or sewer lines that adjoin corner lots, the primary service frontage shall be assessed for the total frontage and the secondary frontage shall be exempt for up to 150 lineal feet of frontage or the primary service frontage, whichever is less.

Where water and/or sewer lines do not extend completely across the customers property, the fee shall apply to the length of the extension.

Out of City water service may be provided on a case-by-case basis or in a regional basis by Council action. Sewer service requires the property owner to petition for annexation and requires water service per City standards.
